# VALIDATION OF THE 33<sup>rd</sup> GENERAL ASSEMBLY ORDINARY SESSION

MAY 12, 2019 - LISBON - PORTUGAL

#### Dear Members:

1. Unfortunately, we were not able to hold the 33<sup>rd</sup> General Assembly Ordinary Session as schedule for May 12<sup>th</sup> 2019 in Lisbon, Portugal. Among others, the main reason was that many members with right to vote did not attended the Summit 2019 and many members attending the Summit had not paid their yearly cotization, so had no right to vote. As the Vice President for Legal and Administrative Affairs informally checked on the number of members present or represented, we found out that we would not have quorum to efficiently hold and decide on the session.

- 2. In my capacity of President, in consultation with the Vice President for Legal and Administrative Affairs and acting according to article 32 letter I of the Constitution, I took the decision to withhold the 33<sup>rd</sup> GA Ordinary Session, and bring it about discussions with the EB Members on how to proceed to reschedule the GA.
- 3. Analyzing the 33<sup>rd</sup> General Assembly Ordinary Session, the main points for discussion were the Report of the 32<sup>nd</sup> Session of the Quadrennial General Assembly held in Geneva, Switzerland on December 15<sup>th</sup> 2017, the Presentation and Approval of the Report of Activities 2018, the Presentation and Approval of the Financial Report 2018, which was included in the Report of Activities.
- 4. Taking into account that members received previously these documents, and no questions or solicitations for explanation or additions arrived before the GA, our decision to withhold the GA was justified.
- 5. The next points, Presentation and Approval of the EB proposal for the Mid-Term Revision of the Strategic Framework for the 19<sup>th</sup> Constitutional Mandate 2018-2021 and the Presentation and Approval of the EB rules of procedures proposal for the establishment of the National Focal Points were not finalized and were not discussed by the EB in order to present good documents to be discussed and approved by the GA.
- 6. The Director for Coordination and Outreach worked very hard with the appointed focal points to produce a concept document, made reports on theirs meeting, compiled ideas and on February 21<sup>st</sup> send the documents and reports to the EB Members, but no reactions was received. The reality is that we did not had time to discuss to present a reviewed and concluded documents to the GA.
- 7. So, it is true that these two points of the agenda could not be presented to be discussed and approved.
- 8. On the other hand, the negotiations for the Summit 2019 was very intense, and it took a lot of time to discuss and formulate a good program with the Portuguese Government, the UN and partners, and personally I had no time to dedicate the amount of time demanded by these two issues.
- 9. On the other hand, we had an extraordinary Summit. I heard from many members and guests that the 2019 WFS was one of the best of the few past years, regarding the contents, the speakers and the technology introduced. Indeed, we have to become more digitally linked!
- 10. Nevertheless, I have discussed the Agenda of the 33<sup>rd</sup> General Assembly Ordinary Session with our Latin America Members, by the way all of them with rights to vote and giving us the necessary quorum to validate the GA Session and after discussing with the Vice President for Legal and Administrative Affairs, we propose to discuss the agenda of the 33<sup>rd</sup> GA Ordinary Session with the EB Members, adding them to the quorum and proceed with a report to be approved on the 34<sup>th</sup> GA Ordinary Session.
- 11. Having that in mind, we are sending to you again the 33<sup>rd</sup> GA Ordinary Session Agenda and support documents, proposing that all the EB Members read them and for each point of the Agenda present in written your remarks and your vote to the President.
