I. Message of the Executive Board

19th Constitutional Mandate 2018-2021



Dear Members,

We, Members of the Executive Board of the 19th Constitutional Mandate 2018-2021, have the honor to present to you the Annual Report of Activities for 2019.

The present Report of Activities reflects the work of the Executive Board with individual members, the work of the President with the Vice-Presidents and Advisors and our achievements. But in fact the important merit of the year of 2019 it was the very intense and continuous exchange with different governments, institutions, civil society organizations on the next steps to take for joining efforts on the implementation of the SDGs especially at the Local Level and in the Family.

Administratively speaking, three areas have been delimitated to deal with our specific needs.

- Substantive Area where the President together with the Vice-President for Family Policy and Programs Implementation and the Director of Coordination and Outreach worked together reviewing the Secretariat Rules of Procedures to adapt to the new composition according to the amendments done to the Constitution as well as with the appointed task-force on the Rules of Procedures for the implementation of the National Focal Points in order to accomplish the Strategy IV – Implementation of Programs to respond to Member's needs of the Strategic Framework 2018 – 2021.
- 3. Communications Area where the President with all Executibe Board Members discussed intensively about the best way to successfully accomplish the Strategy VI- Communicating WFO Message of the Strategic Framework 2018 2021. We are straggling on our communication methods since 2017, not only with members but also with the regular communication among the Executive Board Members. Discussions and deliberations included improving WFO's Communication through Social Media, as our website, Facebook Page, Instagram, Newsletter and others.

The work done during the year 2019 and up to May 2020, to fulfill the Decisions GA32/09/17, gave us an incredible opportunity to evaluate our Strategic Framework implementation in the past decade, to analyze the gaps and consequently all the reviews we have to perform to update our planning methods, modernize the tools for implementation and reporting.

The Executive Board prapared proposals for the Mid-Term Revision of the Startegic Framework 2018 – 2021 to be presented and approved by the 34th General Assembly Ordinary Session in 2020.

The result of our work in 2019 is reflected in this Report. We wish to all WFO Members a good reading, analyzing and your constructive comments in order to refine our work to respond your expectations.

IV. Action Plan 2019 Implementation according to the Strategic Framework 2018-2021.



The Strategic Framework 2018-2021 approved by the 32nd General Assembly Quadrennial Session held in December 15th 2017, aspires to fulfill the World Family Organization's vision as well as its main objective to represent families of the world at all levels, to defend their interests and to act with them and for them vis a vis with governments at national and local level, and the international community.

The main goal of the Strategic Framework 2018-2021 is to ensure that WFO's message is widely disseminated, leading to enacting family focused public policies that contribute to the sustainable social, economic, environment and cultural development.

The Strategic Framework 2018-2021, in addition to its constitutional frames for actions, includes five substantive actions, as part of the Annual Plan of Action Implementation directed to:

- 1- Promoting Family Focused Public Policies
- 2- Fostering Implementation of the Sustainable Development Goals (SDGs) from a Family Perspective & Focusing at the Local Level
- 3- Supporting Migrant & Refuge Families to Better Cope with Their New Realities
- 4- Strengthening WFO's Outreach & Partnerships
- 5- Strengthening WFO's Communication & Mobilization Instruments

The necessary regulations for the substantive actions introduced are still in process of discussions at the Executive Board Level and approvals by the 34th General Assembly Ordinary Session to be held in May 2020 as part of the Mid-Term Strategic Framework Review, therefore the report of its implementation will be shown only at the part of the Report of Plan of Action of 2019.





I - <u>Strengthening Family Perspectives on the International, Regional, National</u> and Local Agendas by establishing new partnerships, alliances and networks and consolidating the existing ones – 2019.

The implementation of this Strategy was delegated to the President, Executive Board Members and Staff.

The main objective of this Strategy is to:

- 1. Insure continued fruitful cooperation among all WFO partners in different instances and level;
- 2. Expand the links with other NGOs and Civil Society;
- 3. Expand WFO's relationship with municipalities and the private sector, exploring areas with potential and mutual interest for cooperation
- 4. Expand affiliation of Families all over the world on the category of the Families of the World as a drive to bring Families itself to the different structures of the Organization.

The expected results of this Strategy is to:

- 1. Strengthen the cooperation with the UN System and establish new international partnerships, alliances and networks consolidating WFO's international leadership on Family Issues
- 2. Increase membership in all WFO's categories
- 3. Increase sources of WFO's finances
- 4. Introduce Family Issues on the International Agenda
